



## **PRIVACY NOTICE ON PERSONAL DATA PROTECTION REGARDING Video-surveillance, Closed circuit television (CCTV)**

The objective of this Notice is to inform you about the collection and processing of your personal data in line with the applicable Data Protection Regulation 2018/1725<sup>1</sup>.

#### **1. Why does F4E process my personal data? Whose data is processed?**

For the security and safety of its buildings, assets, staff and visitors, Fusion for Energy Barcelona operates a video-surveillance system with the following cameras:

- Eleven cameras on the ground floor: two in the reception desk, one on the catering area and the external door CCIB, one on the sea-external door of the CSU open space, one on the Aula Mar 2, one on the Dual Use storage, one on the Willy brandt-CSU storage (door for providers directly accessible from the street) one on the F4E Lounge, and three on the cafeteria area (one of them on the door directly accessible from the street).

- One camera on each of the lift halls of F4E floors: 2nd, 3rd, 7th, 8th, 9th, 10th, 11th, 12th, 13th.
- One camera for the IT room on the 7th floor.

- One camera for the IT room on the 2nd floor. The purpose of this surveillance is detecting, deterring and preventing all kind of attacks, illegal access or other incidents (e.g. theft, vandalism) and health and safety issues (e.g. flood, fire, application of the Health and Safety measures in effect and traceability in case of disease contamination).

The processing will be done through some network cameras connected to AEOS software.

The system is not used for any other purpose, such as monitoring the work of employees or monitoring the presence of staff or contractors. Nor is the system used as an investigative tool (other than investigating physical security and safety incidents such as thefts or unauthorised access).

#### **2. What is the justification for the processing?**

Processing necessary for:

(a) performance of tasks in the public interest attributed by EU legislation (including management and functioning of F4E) 1

- Council Decision of 27 March 2007 “establishing the European Joint Undertaking for ITER and the Development of Fusion Energy and conferring advantages upon it” - 2007/198/Euratom, as last amended by Council Decision of 10 February 2015 (2015/224 Euratom), O.J. L 37, 13.2.2015, p.8, in particular Article 6 thereof;

- Statutes annexed to the Council Decision (Euratom) No 198/2007 “establishing the European Joint Undertaking for ITER and the Development of Fusion Energy and conferring advantages upon it”, as last amended on 10 February 2015, in particular Article 10 thereof.

### 3. Which data is F4E processing?

(a) **General personal data:**

The video-surveillance system makes use of conventional systems which record digital images with indication of time, date and camera number.

The CCTV interconnects its system with AEOS system, and it does not use covert surveillance, sound recording, or “talking CCTV”.

(b) **Sensitive personal data** (Article 10)

### 4. Who has access to my data?

The following recipients have access to the personal data processed:

- Security guards
- CSU Process owner/Head of CS Unit
- HR Officer responsible
- Head of HR Unit
- Head of Administration
- AEOS responsible of the F4E contract may be consulted regarding if deemed necessary by the Appointing Authority for a specified case
- Another person internally may be consulted regarding if deemed necessary by the Appointing Authority for a specified case
- ICT Officer responsible for the dedicated storage, if necessary for technical support

Also, if appropriate and necessary, for monitoring or inspection tasks, access may be granted to:

- Director of F4E
- Head of the Legal Service Unit, and/or responsible Legal Officer
- F4E DPO and Anti-Fraud & Ethics Officer
- IAC / IDOC

### 5. How long does F4E store my data?

The video-surveillance material is stored in the storage system for 21 days, and is automatically deleted after this period.

(When cameras are installed for purposes of security, safety and access control, three weeks should be, in principle, more than sufficient for security personnel to make an informed decision about whether they need to retain any footage for a longer period in order to further investigate a security incident or use it as evidence.)

### 6. Does F4E intend to transfer my data to third countries or International Organizations?

### 7. What are my rights in relation to my data and how can I exercise them?

You have the right to access your personal data, to correct any inaccurate or incomplete data, to request restriction or erasure, or to object to the processing, pursuant to Articles 14(3) and 17-23 of Regulation 2018/1725.

Any request to exercise one of those rights should be directed to the Controller (Osmar.naredo@f4e.europa.eu). Where you wish to exercise your rights in the context of one or several specific processing operations or files, please provide their description and reference(s) in your request.

Exceptions based on Article 25 of Regulation 2018/1725 may apply. In that case, the data subject shall be informed of the principal reasons for applying such restrictions.
